## **Davistown-Empire Bay residents invited to talk about life on the floodplain**

Central Coast Council is preparing a Floodplain Risk Management Study for the areas of Davistown-Empire Bay as part of the NSW Government's Floodplain Management Program.

Residents living in the suburbs of Davistown, Empire Bay and parts of Bensville are invited to have their say on the next phase of the study of the Davistown-Empire Bay catchments.

Council's Acting Director Environment and Planning, Brett Sherar said that the Floodplain Risk Management Study is an important part of Council's responsibility.

"We know that flooding has the potential to cause considerable damage and disruption to a community, and with this study we hope to put in place plans to mitigate the risks," Mr Sherar said.

"By asking our community to share their experiences, particularly since the last time this study was conducted almost 10 years ago, we can make the necessary changes required to plan for the future."

Properties owners identified as being within the floodplain are being directly invited to participate in a postal survey. Drop-in sessions will also be held where residents can find out more.

Central Coast Mayor Lisa Matthews said Council was keen to hear from the community.

"The best way to plan for the future is to combine the science and modelling with the lessons learnt by those living within the floodplain," Mayor Matthews said.

"I would encourage the Davistown and Empire Bay communities to come along to the sessions we are holding, complete the survey and sign up to stay informed as we plan for the future."

# Davistown and Empire Bay Floodplain Risk Management Study and Plan



**In 2010 Central Coast Council completed a Flood Study for the suburbs of Davistown, Empire Bay and Bensville. The study identified flood risks in the local area. Council, with the support from the NSW Government’s Floodplain Management Grant Program, is now undertaking a Floodplain Risk Management Study and Plan (FRMSP) to look at ways to manage flood risk. Council is seeking input from the community on how to best manage flooding.**



In 2010 Council completed a Flood Study for Davistown and Empire Bay. In 2015 Council also adopted a FRMSP for the Brisbane Water foreshore.



Flooding has occurred within the study area due to ocean storms, local intense rainfall and extreme tides.



More than 2,000 properties within the study area could be affected by flooding in extreme ocean and rainfall events.



Council is asking the community what flood risks they are concerned about and how they would like Council to address the risks.



At Council we know some parts of the Local Government Area (LGA) are more prone to flooding than others and we’re committed to finding solutions to reduce the social and economic damages of flooding.

A Flood Study was completed for Davistown and Empire Bay in 2010 and The Brisbane Water Floodplain Risk Management Study and Plan was completed in 2015. The studies found a range of flooding issues including flooding of private properties, roads and public space. Flooding is caused by creek and estuary flooding during large rainfall events, as well inundation from ocean storms.

The Floodplain Risk Management Study and Plan will be looking at options to manage flooding and its consequences. This may include drainage upgrades, foreshore barriers, raising roads, property filling, drainage easements, planning and development controls, community awareness programs or evacuation procedures.

Council will be identifying potential options with the input from the community and will then assess the options and identify what actions Council, SES and the community can undertake to improve flood risk.
